Subject: Amended Notice of Hearing for Consideration of Proposed Amendments and/or Additions to the Nevada Cannabis Compliance Board Regulations 5.110, 5.112, 5.125, 5.127, 6.065, 6.072, and 6.140

The Nevada Cannabis Compliance Board (CCB) will hold a public hearing for the purpose of considering the adoption, amendment or repeal of the regulation(s) stated below.

In compliance with the Governor's Emergency Directive #006 (dated March 22, 2020), and Emergency Directive #029 (dated July 31, 2020), the consideration of the adoption, amendment, or repeal of the regulations stated below during the meeting of the CCB may be conducted by means of electronic communications. If the meeting is conducted by means of electronic communication, then members of the public may access the meeting at the time noticed herein by live stream link for the October meeting posted on the CCB's website <https://ccb.nv.gov/public-meetings/>.

Purpose: The need and purpose of the proposed changes to the NCCRs is to establish the procedure for submitting a complete list of owners of a company, to require proof that a licensee has a right to a property it is requesting a transfer to, listing training and instruction requirements for agents and volunteers at cannabis establishments, and collecting comprehensive demographic information on owners, managers, and agents.

Regulation 5.110: An amendment on the procedure of notifying the Board when an owner exceeds 5 percent interest in a cannabis establishment.

Regulation 5.112: An amendment to the procedure for waiving requirements of NCCR 5.110 regarding any transfer of ownership of less than 5 percent. Specifically, procedures for the cannabis establishment to provide as complete a list as possible of all owners of any ownership interest in the cannabis establishment.

Regulation 5.125: An amendment to the procedure for waiving requirements to obtain a cannabis agent registration card for any owner, officer, and board member who holds an ownership interest of less than 5 percent. Specifically, procedures for the cannabis establishment to provide as complete a list as possible of all owners of any ownership interest in the cannabis establishment.

Regulation 5.127: An addition to the NCCR creating the procedures for a publicly traded company to provide a list of owners to the Board.

Regulation 6.065: An addition to the current regulation adding a requirement that the licensee must provide documentation that it either owns or has the right to operate a cannabis establishment at the new location.

Regulation 6.072: An addition to the NCCR regarding requirements for the training and instruction required before an agent may begin work or service as volunteer at a cannabis establishment.

Regulation 6.140: An addition to the NCCR regarding the gathering and maintenance of comprehensive demographic information concerning each owner, manager, and holder of a cannabis establishment agent registration card.

The proposed changes to the regulations will be considered by the CCB in accordance with the provisions of NRS 678A.460(1)(c), which provides that on the date and at the time and place designated, any interested person or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally. IF THE OCTOBER CCB MEETING IS HELD BY MEANS OF ELECTRONIC COMMUNICATION, ANY PERSON DESIRING TO PRESENT STATEMENTS, ARGUMENTS OR CONTENTIONS CONCERNING THE PROPOSED REGULATION CHANGES MUST PROVIDE SUCH IN WRITING TO THE EXECUTIVE ASSISTANT AT regulations@ccb.gov by 9 P.M. on the day prior to the meeting. Written public comment received after 9:00 p.m. the day before (or during the open meeting) will be included in the record as reasonable, in accordance with Governor's Directive #006 as applicable by Directive #029.

These items will be heard by the CCB at the October 20, 2020 meeting, and may be continued and heard at subsequent meetings of the CCB as required to effectuate the above-stated purposes.
