Re: Demographic Report of Nevada's Cannabis Industry

#### <u>Purpose</u>

This report, required by Assembly Bill 533 (2019), details demographic data collected for active agent registration card holders within Nevada's cannabis industry. The legislation states that: "The Board shall adopt regulations providing for the gathering and maintenance of comprehensive demographic information, including without limitation, information regarding race, ethnicity, age and gender, concerning each: (a) Owner and manager of a cannabis establishment. (b) Holder of a cannabis establishment agent registration card." (AB533 Sec. 64(2)).

As such, the Nevada Cannabis Compliance Board (CCB) promulgated the Nevada Cannabis Compliance Regulations (NCCR 1-14). Pursuant to NCCR 6.140, the CCB will conduct a demographic survey annually to collect comprehensive data on the industry. Recipients are required to complete the survey.

In preparation for the 81<sup>st</sup> (2021) Legislative Session, the CCB compiled this report to serve as a reference to inform future decisions which will impact Nevada's cannabis industry.

#### Background

Prior to this report, there has been no formal data available detailing the demographic makeup of Nevada's cannabis industry. As such, this report establishes a baseline and will allow for a more comparative and comprehensive analysis of data and trends year over year within the industry.

#### **Method**

For the purpose of this report, the CCB conducted a survey, which included five demographic questions. The survey was sent to all active agent registration card holders as of January 1, 2021. Of the 9,890 potential respondents, 5,501 surveys were submitted within a designated two-week response period.

This includes a nearly 100% response rate from industry executives defined as the owners, officers, or board members of cannabis establishments. For scope, 744 survey respondents identified as an owner, officer, or board member of one of Nevada's 232 cannabis entities. Those entities combined hold a total of 739 active licenses or certificates to operate in Nevada.

Below are the five demographic questions/prompts respondents were asked to complete. The option 'Prefer not to answer' was included for each.

- 1. What is your gender?
- 2. Are you of Hispanic, Latino, or Spanish origin, such as Mexican, Puerto Rican or Cuban?
- 3. Select your race. Select all that apply.
- 4. What is your age?
- 5. What is the highest level of education you have completed?

#### Results

Of the total respondents:

- 42% are affiliated with a Cannabis Cultivation Facility.
- 28% are affiliated with a Cannabis Production Facility.
- 7% are affiliated with a Cannabis Testing Laboratory.
- 49% are affiliated with a Cannabis Dispensary/Retail Facility.
- 12% are affiliated with a Cannabis Distribution Facility.
- 8% are affiliated with another type of cannabis establishment (Consultant, Delivery Driver, Vendor, etc.).

Note: Total percentage above is >100% because respondents were instructed to select all that apply.

- 58% identified as Male; 38% identified as Female.
- 24% identified as being of Hispanic, Latino, or Spanish origin.
- 53% identified as White.
- 44% identified as being in the age group: 25 through 34 years old.

Responses below are aggregated by position held within the industry (i.e. owner, board member, employee, etc.).



#### **Industry Impact**

Since the CCB's commencement of operations on July 1, 2020, there have been no open licensing rounds. Pursuant to NRS 678B, in determining whether to issue a license, among other considerations, the Board will factor in "the diversity on the basis of race, ethnicity, gender or veteran status of the applicant or the persons who are proposed to be owners, officers or board members."

Additionally, pursuant to NRS 678A, the Board "will establish a pilot program for identifying opportunities for an emerging small cannabis business to participate in the cannabis industry."

Demographic data collection and analysis will assist in the CCB's efforts to prioritize diversity and inclusivity in any new licensing rounds and future pilot programs.

#### **Limitations**

In this inaugural survey, the response rate was more than 50% of the cannabis industry and nearly 100% of industry executives. In order to fully understand the scope of the industry, the CCB will continue to refine the survey process with the goal of improving the response rate year over year. This can be accomplished through further refinement of demographic and identifier questions and choices within the survey and the agency's request for constructive feedback from respondents.

#### Conclusion

In executing the state's first undertaking of a demographic analysis of Nevada's cannabis industry, the CCB looks forward to continuing to collect and provide meaningful data on this industry for state legislators, stakeholders, and other interested parties.



# Please select the cannabis establishment type with which you are affiliated. Select all that apply.



# What is your gender?



# Are you of Hispanic, Latino, or Spanish origin, such as Mexican, Puerto Rican or Cuban?



# What is your race? Select all that apply.



# What is your age?


