# COVID-19 Guidance For Sales Facilities



**Heads Up:** Previous Nevada DMV extensions for expired driver's license identification cards for motorists under age 65 have expired. As such, cannabis retail stores should no longer accept an expired Nevada issued driver's license as an acceptable form of ID for anyone under 65.

Motorists age 65 and older have been given additional time to renew their driver's licenses. Download that extension letter, [here](#).

Per Nevada's safe reopening plan, capacity limits for public gatherings, events, and many businesses increase beginning March 15. There are no changes to capacity limits for medical and recreational cannabis sales facilities which remain at 50% occupancy.

The CCB continues to encourage delivery and curbside options in addition to in-store sales.

## Frequently Asked Questions

*Q: What is an acceptable form of ID to use when purchasing cannabis or cannabis product from a sales facility?*

A: Per Nevada Cannabis Compliance Board Regulation (NCCR) 7.020, a cannabis sales facility may not sell cannabis or cannabis products to any person unless that person produces a form of valid identification.

This includes:

- U.S. state-issued driver's license
- U.S. military identification card
- Merchant Mariner Credential (or other similar document issued by the U.S. Coast Guard)
- Passport issued by or recognized by the U.S.
- Permanent resident card issued by the U.S.
- Tribal identification card issued by a tribal government

*Q: Can the CCB clarify its interpretation of 'telephone' in NCCR 7.050 Section 5.a. regarding delivery to consumer?*

A: Confirmation by telephone may include a phone call and/or the use of text messaging to verify the identity of a consumer.

*NCCR 7.050 Section 5. "A cannabis sales facility shall not deliver cannabis or cannabis products to any person other than the consumer who ordered the cannabis or cannabis products. Before delivering cannabis or cannabis products to a consumer, the cannabis establishment agent delivering the cannabis or cannabis products for a cannabis sales facility shall: (a) Confirm by telephone that the consumer ordered the cannabis or cannabis products and verify the identity of the consumer;"*
