As of March 22, Nevadans 16+ with underlying health conditions are eligible to receive the COVID-19 vaccine. Starting April 5, vaccines will be available for all Nevadans 16+.

## Submit Your Input: Proposed Changes to NCCR

The CCB is seeking input on proposed amendments and/or additions to Nevada Cannabis Compliance Regulations (NCCR) 1.135, 4.035, 4.040, 4.050, 4.055, 4.135, 5.140, 6.035, 6.040, 6.080, 6.120, 11.010, 11.015, 11.025, 11.040, 11.050, 11.070, 11.075, 12.015, 12.045, and 13.020.

The CCB will accept input until 5:00 p.m. PST on **April 9, 2021**. All comments should be emailed to: [regulations@ccb.nv.gov](mailto:regulations@ccb.nv.gov).

Following the input period, a formal public workshop will be noticed and held, during which the public can submit additional comments.

## Frequently Asked Questions

*Q: Is CCB approval needed for menu changes such as new flavors or ingredients?*

A: Yes. Per Nevada Cannabis Compliance Board Regulation (NCCR) 9.045.4:

*"4. Any change in the recipe, production run size or equipment used to produce an edible cannabis product must be approved by the appropriate Board Agent."*

Menu approvals are processed through the Accela cannabis customer portal. New shelf life testing and homogeneity testing pursuant to NCCR 9.040 and 9.045 may also be required depending on the change.

*Q: Can the CCB clarify the term "Pathogenic E. coli" as specified in NCCR 11.050.*

A: Test methods for detection of pathogenic E. coli must be capable of detecting the following seven strains - E. coli O157:H7 as well as the Top 6 Non-O157 Shiga Toxigenic E. (STEC) species (O26, O45, O103, O111, O121, and O145).

All laboratories must review their testing procedures for pathogenic E. coli to ensure they are able to meet this capability.
