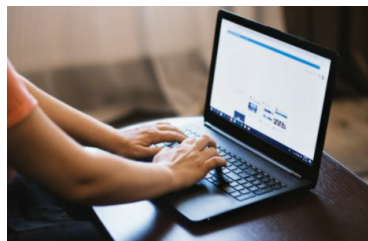
### Signed into Law

Following the close of the 81st Session of the Nevada Legislature, Governor Sisolak signed **SB49**, sponsored by the Senate Committee on Health and Human Services on behalf of the CCB.

## Frequently Asked Questions

*Q: Are CCB offices open to the public?*

A: While many state offices and facilities have returned to a level of pre-COVID operations, an appointment is required to visit a CCB office. Appointments are reserved for the payment of fines/fees.

Those wishing to submit an agent registration card application can do so entirely online through **Accela**. Currently, payment for applications is only accepted via mail.

*Q: How can I submit a payment for the fees and/or fines for my license?*

A: Cash can only be accepted through an in-person appointment **and** when the amount is more than \$2,000. In-person appointments must be scheduled, no walk-ins are allowed. Appointments can be scheduled through the CCB website.
