Per Governor Steve Sisolak and Nevada Health Response, regarding updated guidance on masks issued by the Centers for Disease Control and Prevention (CDC), **fully-vaccinated individuals do not need to wear a mask in most indoor and outdoor locations.**

Additionally, CDC guidance issued on May 13 provides updates on social distancing recommendations for fully-vaccinated individuals. As of May 1, mitigation measures including social distancing guidelines are set by local jurisdictions. As such, cannabis establishments should review and adhere to any updated local ordinances.

Frequently Asked Questions

Q: Are sales facilities required to provide exit bags for all cannabis purchases?

A: Per NCCR 12.015, cannabis or cannabis product must be packaged in an opaque, child-resistant packaging, which must maintain its effectiveness for multiple openings.

If the packaging meets those requirements, an exit bag would not be required for a consumer to leave a sales facility.

An example would include a black pill bottle with a resealable child-resistant cap.

If the packaging is not opaque or is not child-resistant for multiple openings, the cannabis or cannabis product must be placed into a compliant package, such as an exit bag, prior to sale.

Q: Is a production facility required to request an exemption from stamping/molding with the state symbol?

A: Yes. Per NCCR 12.020, stamping or molding is required for edible cannabis products. If a facility believes it is impractical to stamp or mold a product, it must submit [this form](#) for an approved exception.

Q: If a product contains concentrated cannabis, does the specific solvent need to be disclosed?

A: If concentrated cannabis is added to a product or if the product consists solely of concentrated cannabis, a disclosure of the type of extraction process used and any solvent, gas, or other chemical used in the extraction process is required.

A general statement such as "Extracted with hydrocarbons" does not meet this requirement. The disclosure must specify the solvent used, such as "Extracted with Butane."

Q: How can licensees best utilize the 'Approved for Extraction' option in Metrc?

A: The 'Approved for Extraction' option is located within the 'Add Items' section for Metrc. This item type would be used if a user has trim that has failed and CCB approval has been received for extraction.

For example, trim that has been approved for extraction should be re-tagged and categorized as 'Trim for Approval.'
