AB 341 authorizes the CCB to license and regulate cannabis consumption lounges.

Submit Input

The CCB is seeking input on proposed amendments to the Nevada Cannabis Compliance Regulations (NCCR) 1, 6, 7, and 12.

The CCB has created a new online resource page for consumption lounges which includes a tentative timeline and links to public meetings and FAQs.

The CCB has not yet scheduled any open licensing rounds. The CCB will make formal public notice ahead of accepting license applications for consumption lounges. To receive information about public meetings, notices, and open application periods subscribe, [here](#).

Frequently Asked Questions

Q: Can a cannabis dispensary accept an expired driver's license as a valid form of ID?

A: An expired ID may only be considered valid if accompanied by an interim paper document from the DMV.

Review Nevada Cannabis Compliance Regulation (NCCR) 7.020 for the full list of acceptable forms of valid identification.
