Subject: Notice of Hearing for Consideration of Proposed Amendments and/or Additions to the Nevada Cannabis Compliance Board Regulations 1.051, 1.081, 1.083, 6.025, 6.060, 7.060, 11.050, 12.015, 12.020, 12.030, 12.035, 12.040, 12.045, 12.050, 12.070

The Nevada Cannabis Compliance Board (CCB) will hold a public hearing for the purpose of considering the adoption, amendment or repeal of the regulation(s) stated below.

## For Possible Action

**Purpose:** The need and purpose of the proposed changes to the NCCRs is to provide additions to definitions, clarifications on billing for time and effort, time requirement for licensees to become operational, testing requirements for terpenes, and packaging and labeling of cannabis.

Regulation 1.051: Added a definition of "Advertising"

Regulation 1.081: Added a definition on "Derived"

Regulation 1.083: Added a definition of "Edible Cannabis Product"

**Regulation 6.025:** An amendment to add subsection 1(g) to include time and effort will be billed for processing initial applications and removed language in subsection 3 that time and effort will not be billed for processing initial applications.

**Regulation 6.060:** An amendment to add cannabis establishments must become operational within 30 days of receiving final license.

**Regulation 7.060:** An amendment to add new section due to the passage of Senate Bill 168 and addresses curbside operations at cannabis sales facilities.

**Regulation 11.050:** An amendment to remove the requirement for laboratory testing for terpenes in extracts of cannabis (both solvent and non-solvent), edible cannabis, liquid cannabis, and topical cannabis.

**Regulation 12.015:** An amendment to add new language "THIS PRODUCT CONTAINS CANNABIS" which was passed in SB49 and adds the requirement to have the warning "KEEP OUT OF REACH OF CHILDREN" on packaging. Subsection 1(e) is a new section which requires the Nevada Universal Cannabis Symbols to be on all packaging. Subsection 1(f) was added to require the net weight of the product must be on edible packaging. Subsection 2 was amended to clarify that any cannabis or cannabis product must be placed into a package or directly packaged in opaque, child resistant packaging. Subsection 3 was amended to clarify the requirement for packaging materials.

Regulation 12.020: An amendment to add the term "Nevada Universal Cannabis Symbol."

**Regulation 12.030:** An amendment to label requirements to allow for establishments to put their 20-digit license number or their cannabis establishment ID on the label. Subsection 1 was amended to allow for cultivation facilities to securely affix labels or include with the package of cannabis product.

**Regulation 12.035:** An amendment to label requirements to allow for establishments to put their 20-digit license number or their cannabis establishment ID on the label. Subsection 1 was amended to allow for production facilities to securely affix labels or include with the package of cannabis product.

**Regulation 12.040:** An amendment to include a cannabis sales facility may securely affix a label or include with the package or container of usable cannabis. Removed the requirement in Subsection 1(e) that required the date sold to be on the label.

**Regulation 12.045:** An amendment to include a cannabis sales facility may securely affix a label or include with the package or container of usable cannabis.

**Regulation 12.050:** An amendment to subsection 1 requiring sales facilities to provide, upon request, accompanying materials that discloses any pesticides applied to the cannabis plants and growing medium during production and processing. Subsection 2(h) was amended to add "or breastfeeding."

Regulation 12.070: An amendment to add the requirements for advertising of cannabis.

The proposed changes to the regulations will be considered by the CCB in accordance with the provisions of NRS 678A.460(1)(c), which provides that on the date and at the time and place designated, any interested person or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally. Any person desiring to present statements, arguments, or contentions concerning the proposed regulation changes may provide such in writing to the Executive Assistant at <u>regulations@ccb.nv.gov</u> by 9 P.M. on the day prior to the meeting. If oral presentations are permitted, the persons intending to make such presentations must be personally present at the public hearing. Allowances for remote appearance may be made for those with disabilities only, but such requests must be made at least eight calendar days prior to the meeting.

These items will be heard by the CCB at the October 26, 2021, meeting, and may be continued and heard at subsequent meetings of the CCB as required to effectuate the above-stated purposes.
