## CAC Meeting Recap: November 9, 2021

Assemblyman Steve Yeager was introduced as the newest member of the CAC. Appointed by Governor Sisolak, Yeager replaces Daniel Stewart who stepped down earlier this year.

After review, commission members present voted unanimously to approve recommendations regarding public health, public safety, and social equity, diversity and inclusion as discussed. These recommendations will be considered by the Board as it promulgates regulations for cannabis consumption lounges.

## ICYMI: Online ACH Payment Option Launched

## Frequently Asked Questions

*Q: Can I still pay for an agent registration card application with a check?*

A: Applicants may continue to submit a payment via mailed check. To do so, select "Pay Later" to bypass the online payment form when completing the application.

As a reminder, please allow 7-10 business days for the CCB to receive and process payments received via mail.

*Q: How long do I have to update the status of an employee in Metrc?*

A: Newly hired employees should be entered into Metrc within 10 business days.

Additionally, the status of terminated employees should be updated in Metrc within 10 business days.
