20 dismisses with prejudice the Complaint for Disciplinary Action in the above-titled matter.

13 forth in the Complaint and hereby surrender the following Cannabis establishment agent
14 registration cards ("agent cards") issued by the Cannabis Compliance Board (the "CCB")

16 that pursuant to the penalty set forth in the Relief Requested in the Complaint, I will have
17 no opportunity to apply for reinstatement of any agent cards for nine (9) years and eleven

19 4.030(b) and NCCR 4.100.

21 surrender occurs within thirty (30) days of the service of the Complaint.


