Acceptable ID's, Scanner Features and Functions

This is a reminder that, in accordance with Nevada Cannabis Compliance Board Regulation (NCCR) 7.015, 7.020, 15.015, and 15.020, cannabis establishments must adhere to specific protocols for verifying the age of consumers. To ensure compliance, the Nevada Cannabis Compliance Board has outlined the features and functionality required for approved identification scanners. These features include:

- Capable of reading government-issued identifications
- 400 DPI high-resolution imaging
- Scanning window large enough for passports
- Multiple wavelength illumination visible and infrared
- Data and images capture
- Offers a subscription service
- ICAO compliant documents in near infrared
- Reads 1D barcodes
- Reads 2D barcodes from paper documents and most mobile devices
- Reads Magnetic strips
- USB 2.0 high-speed compatible
- The ability to verify and authenticate the identification cards of foreign nationals
- Age verification

Please note that all sales deliveries, curbside pickups, and drive-throughs must exclusively operate Board-approved mobile ID scanners. Requests for equipment should be submitted through the cannabis establishment's Accela portal. Facilities are required to come into compliance with the aforementioned requirements within 30 calendar days. Effective immediately, the use of an approved ID scanner is mandatory.

ACCEPTABLE GOVERNMENT IDS

Pursuant to NCCR 7.020, cannabis sales facilities are prohibited from selling cannabis or cannabis products to individuals under the age of 21. Therefore, customers must present valid identification demonstrating they are 21 years old or older.

- 1. Driver's licenses or other state photo identity cards issued by Department of Motor Vehicles (or equivalent)
- 2. U.S. passport
- 3. U.S. passport card
- 4. DHS trusted traveler cards (Global Entry, NEXUS, SENTRI, FAST)
- 5. U.S. Department of Defense ID, including IDs issued to dependents

ACCEPTABLE GOVERNMENT ID'S CONT.

- 6. Permanent resident card
- 7. Border crossing card
- 8. State-issued Enhanced Driver's License
- 9. An acceptable photo ID issued by a federally recognized, Tribal Nation/Indian Tribe
- 10. HSPD-12 PIV card
- 11. Foreign government-issued passport recognized by the U S.
- 12. Canadian provincial driver's license or Indian and Northern Affairs Canada card (Other foreign driver's licenses and/or government IDs (for example: voter ID cards) should not be accepted)
- 13. Transportation worker identification credential
- 14. U.S. Citizenship and Immigration Services Employment Authorization Card (I-766)
- 15. U.S. Merchant Mariner Credential
- 16. Veteran Health Identification Card (VHIC)
