Public Health and Safety Bulletin 2024-02

The Nevada Cannabis Compliance Board (CCB) is hereby issuing Public Health and Safety Bulletin 2024-02 on July 19, 2024, advising consumers and patients to avoid or take caution when consuming the cannabis which are the subject of this notice.

CCB agents discovered that the following production batches/Metric tag numbers of edible cannabis products were manufactured using an ingredient, Tetrahydrocannabivarin (THCv), from an unapproved source.

All cannabis products properly sold by a licensed cannabis sales facility should have a compliance label on or with the packaging. The name of the production facility and production batch numbers can be found on the label, typically near the top.

The listed sales facilities are requested to display this bulletin in a conspicuous location on their premises for 30 days, to ensure their customers are aware of this information.

The CCB advises consumers to take caution when consuming the identified lot number(s):
