**CANNABIS ESTABLISHMENT RECEIVER
WITH CERTIFICATE OF QUALIFICATION
INITIAL & RENEWAL APPLICATION FORM
(for receivership over a specific cannabis establishment)
(NRS 678B.355 & NCCR 5.195(6))**

Please note the following:

1. This application form is only for a cannabis receiver who holds a Certificate of Qualification.
2. Prior to submitting this form, the receiver applicant must complete an application for a cannabis establishment agent card via the CCB's Accela portal for the cannabis establishment/s for which the receiver applicant is seeking appointment and placement. This will require a full set of fingerprints. You may also be required to provide any additional information or documents to the Board to complete an investigation into your background.
3. Pursuant to NCCR 5.175, unless exigent circumstances exist, the Court appointment of a receiver must take place prior to the Board's approval of a cannabis receiver's application. This form may be submitted prior to Court approval/appointment, though Court approval will be required pursuant to NCCR 5.175.
4. This form shall also be used to renew a cannabis receiver's agent card for a receiver with a Certificate of Qualification, in accordance with NRS 678B.355(4), which states:

A cannabis establishment agent registration card for a cannabis receiver expires 2 years after the date of issuance and may be renewed upon:

- (a) Resubmission of the information set forth in this section; and
- (b) Payment of the renewal fee set forth in [NRS 678B.390](#).

For renewals, please complete all sections of this form, with current, updated information, including a resume or CV updated within the last 30 days. You must also complete an agent card renewal via Accela. Renewal applications must be submitted at least 45 days prior to the expiration date of the cannabis receiver's agent card.

In addition to the foregoing information, the Receiver Applicant with a Certificate of Qualification must provide the following documents and information:

1. A copy of the Certificate of Qualification.
2. A resume or curriculum vitae, which has been updated within 30 days of this submission, describing and detailing:
 - Your experience as a court appointed receiver.
 - Your experience in or knowledge of the cannabis industry in Nevada and/or any other state.
 - Your knowledge and skills necessary to make reasonable financial decisions with respect to the finances of a cannabis establishment subject to a receivership.
3. Proof of liquid assets in at least the amount of \$250,000, proof of professional and/or E & O liability insurance covering the acts and/or omissions of the receiver for his duties as a cannabis establishment receiver, or proof of ability to finance the receivership through receivership certificates or other secure sources of funding.
4. Proof that the proposed receiver has notified, or has made a good faith effort to notify, the point of contact and owners of record with the Board for the subject cannabis establishment of the proposed receiver's application and/or court appointment as a receiver.

5. An Application Fee or Renewal fee of \$150, which must be paid through the application for a cannabis establishment agent card via the CCB's Accela portal for the cannabis establishment/s for which the receiver applicant is seeking appointment and placement.
