Buy Legal at Nevada Dispensaries and Lounges

(Las Vegas, NV) Ahead of 4/20, Nevada Cannabis Compliance Board (CCB) issues an important message: **only licensed, only legal**.

The CCB strictly regulates 384 operational cannabis establishments across the state, including 106 dispensaries and two consumption lounges. Cannabis grown, harvested, tested, packaged, and sold in Nevada meets stringent requirements from seed to sale. This includes approval of all ingredients, bans on harmful pesticides, independent laboratory testing, and child-proofing measures. Every plant, every product is tracked by operators and regulators, including 24/7 video surveillance verification. Regular audits and inspections confirm compliance and sanitation standards. Certificates of Analysis for all products sold at licensed Nevada cannabis retailers provide consumer protection and transparency. These Certificates of Analysis verify potency and product safety before purchase.

The illicit market replicates cannabis establishments and practices. Here's how to know what's real:

- Visit https://ccb.nv.gov/list-of-licensees/. Businesses not listed here may be selling intoxicating hemp, CBD, and low potency (less than .3%) THC products but are not licensed to sell cannabis in the State of Nevada.
- Licensed cannabis establishments may offer delivery to a private residence. However, any delivery to a resort casino is an indicator the cannabis is illegal and unsafe. Furthermore, no licensed cannabis operators are located within 1,500 feet of a casino.
- Any sale over social media is a red flag. ID verification is required at a licensed cannabis retailer.
- You can't see the products inside licensed cannabis establishments from the street. Additionally, if a product isn't behind a barrier, it isn't cannabis from a licensed operator.
- Ask for a Certificate of Analysis. A Certificate of Analysis is available for every product at a licensed cannabis establishment and must be provided upon request.

A <u>third-party study</u> estimates 30% of cannabis purchased in Nevada is illicit. Purchasing from a licensed cannabis retailer supports Nevada entrepreneurs, scientists and skilled workers while contributing to the <u>State Education Fund</u>.
