The public is hereby noticed that items on this agenda are stacked. The Cannabis Compliance Board (CCB) will take public comment on any matters within its jurisdiction, control, or advisory power. The Board is not permitted to deliberate or take action on any items raised during the public comment period until the matter itself has been specifically included on an agenda as an item upon which action may be taken by the Board. Comments by the public may be limited to three minutes as a reasonable time, place, and manner restriction, but may not be limited upon viewpoint. This meeting will be conducted via remote technology and at two designated physical locations where members of the public may attend and participate. In accordance with Section 4 of AB 64 (2025), amending NRS 241.023, the CCB is not required to include remote public comment instructions in this notice, as physical access for public participation is being provided. However, public comment may be accepted via remote technology using the access information provided in this agenda. Content may be redacted due to inappropriate language. All written public comments shall, in their entirety, be included as part of the public record. Prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the Board may refuse to consider public comment regarding the matter pursuant to NRS 678A.560 and NCCR 4.080. In the event technical difficulties prevent these proceedings from being broadcast, the CCB, at its discretion, may conduct the meeting without the proceedings being broadcast.
