

Nevada Cannabis Compliance Board

Meeting Minutes August 6, 2026

The Nevada Cannabis Compliance Board (CCB) held a public meeting at 700 E. Warm Springs Road, Las Vegas, Nevada beginning at 9:00 a.m. on August 6, 2026.

Chair Berry called the meeting to order.

Executive Director Michael Miles called roll, and a quorum was established.

Chair Berry, Members Rath, Mazzorana, and Merritt were present via Teams.
Vice Chair Durrett was not present.

Chair Berry announced for the record that the board is not permitted to deliberate or act on any of the items during public comment unless the subject is included on the agenda as an item on which action may be taken. Board members will refrain from commenting or responding to public comments. Chair Berry asked that comments regarding the CCB Language Access Plan be held until the end of the meeting.

I. Public Comment

Chair Berry asked for public comment and there was none.

II. Consent Agenda

- a. Consideration of Approval of the June 18, 2026 Cannabis Compliance Board Meeting Minutes

Chair Berry opened Agenda Item II for discussion. There was no discussion.
Chair Berry moved to approve the Consent Agenda.

Member Rath seconded. Members Rath, Mazzorana, and Merritt said aye. Motion carried.

III. Transfers of Interest

- a. Vireo Growth Inc (C062, C070, C094, P063, P088, D107, D152, D165, D200, RD216, RD217, RD218, RD221, RD397, RD398, RD399, RD401, CLA005, CLA016, T024, T056, T095) (TOIs #2600006, #2600007, #2600007A) requesting approval to acquire The Hawthorne Gardening Company LLC, M3 Wellness LLC (RD673), and C21 Investments Inc, Silver State Relief LLC, Silver State Cultivation LLC (C001, P001, D002, D204, RD400)

Chair Berry asked if there was someone from staff prepared to speak on this matter.

Rachel Branner spoke and summarized the agreement. She said a monopoly investigation was conducted and that Vireo will remain below the threshold in Clark and Washoe counties. Vireo also requested a waiver of NAC 678B.119 pursuant to NAC 678B.112. She said no areas of concern were identified and remained available for questions. Lori Rogich, Sean Apfelbaum, Loral Langemeier, and Daniel Giudici were introduced to the board.

Chair Berry invited the parties to speak.

Lori Rogich spoke on behalf of Vireo Growth Inc, Deep Roots Harvest Inc, and Deep Roots Aria Acqco Inc. She introduced Sean Apfelbaum, counsel for Vireo Growth Inc, and John Marshall, Chief Operating Officer of Deep Roots, to the board. She stated others were present via Zoom.

Ms. Rogich took a moment to express condolences to Agent Michael Covington's family, members of the board, and CCB staff, and express how much they enjoyed working with Agent Covington. She expressed appreciation to Director Miles, Chief Branner, and Agent Mosley for their continued work on this matter.

She requested that the waiver be considered with the transfer requests by the board.

Chair Berry asked for comments from the board.

Member Rath said the item seemed to be in order, based on staff analysis, and he would be supportive of it. There was no additional comment.

Chair Berry moved to approve Agenda Item III with the requested waiver subject to the condition that the waiver expires on the next agenda date.

Member Rath seconded the motion.

Chair Berry asked for discussion regarding the motion. There was no discussion. Chair Berry called for a vote, and Members Rath, Merritt, and Mazzorana said aye. Motion carried.

IV. Hearing on the Summary Suspension in the matter of CCB v. NLV Mayflower Holdings LLC(C145)

Chair Berry stated that the issue has been brought before the board to determine whether the summary suspension should be lifted or left in place. He said that both parties would make their presentations, call witnesses, cross-examine witnesses, and board members would ask questions. The board would act on the matter once presentations were made and questions were addressed. Chair Berry asked if either party had any procedural or evidentiary issues to bring up before beginning.

Senior Deputy Attorney General Matthew Feeley addressed the board and stated that the hearing no longer needed to go forward. This matter is pursuant to NRS 233B.127 which requires a hearing unless the parties agree to continue the suspension. He said the parties have agreed to continue the suspension while they work to resolve the underlying matter.

Amanda Connor of Connor & Connor, counsel for the respondent, addressed the board and said her clients reserve all their claims, rights, and defenses, but are hoping to resolve this quickly.

Chair Berry asked if there were any comments from the board. Member Rath thanked the parties for working together to come to an agreement and expressed his hope that they will continue to work to resolve the issue.

V. Public Comment on the CCB Language Access Plan

Chair Berry opened Item V for public comment. Amanda Connor spoke and stressed the importance of having a Language Access Plan given the difficulties her clients have experienced communicating with CCB agents on the prior matter.

Chair Berry asked if staff had any comment to add.

Julia Butler, Education Information Office and Language Access Liason for the CCB addressed the board and stated that pursuant to NRS 232.0081 the LAP is subject to public comment before being submitted. She addressed Amanda Connor and said that her clients are not responsible for providing translation services, the agency is. Ms. Butler said she is available to help facilitate those services.

Ms. Butler said that updates to the document have not changed the process of assisting limited English proficiency individuals but modernizes current capabilities and goals.

Chair Berry asked for any comments. Member Rath asked Ms. Butler how the CCB would address language needs that the CCB can't internally support. Ms. Butler said the CCB uses state resources to meet those needs.

There were no other comments.

VI. Public Comment

Chair Berry asked for additional public comment. There was no additional comment.

VII. Adjournment
